Payroll Giving

Payroll giving is such an easy and worthwhile initiative that's been successful all over the world!

Here's how it works: every month, your employees can choose to donate a discretionary amount to Clatterbridge Cancer Charity through their payroll. The best part? It's a pre-tax contribution!

As a business, you can use a Payroll Giving agency to set the scheme up on your behalf. Once the scheme is in place, you can make the agreed deductions every time you run payroll. This money will come out of your workers' pay after National Insurance but before tax. Then simply send the donated money to your agency, and they will pass it on to us.
